As a condition precedent to granting approval of any request for a change, alteration or addition to an existing basic structure, that the applicant, the heirs, and assigns thereto, hereby assume sole responsibility for the repair, maintenance or replacement of any such alteration, or addition. It is understood and agreed that the "Association" et al, are not required to take any action to repair, replace, or maintain any such approval change, alteration, or addition, or any damage resulting there-from for any reason to the existing original structure, or any other property. **THE HOMEOWNER ASSUMES ALL RESPONSIBILITY AND COST FOR ANY ADDITION OR CHANGE AND ITS FUTURE UPKEEP.**
